#### Year End Update

2022 continued to be very challenging. The Association finally utilized their compliance committee; hopefully, in the end, this will prove to be helpful to the property values.

In trying to navigate the current pricing and inflation, we were still able to finish the landscaping project and paint, clean, and purchase new fixtures for the cabana area.

We are almost at 100% in assessment due with some members still on a current payment plan.

Wish list for next year will be to upgrade security and access to the pool area, and to start looking at the wall again as far as any repair, cleaning, and painting.

## **POOL NEWS**

#### Security

We now have 24-hour security camera surveillance at the pool/tennis court/gazebo/basketball court. The pool is open with some restrictions. When the lights go on in the evening, you must leave the pool.

Residents must have a valid pool pass, even if accompanying another resident.

All residents should practice social distancing.

Children under the age of 14 must be accompanied by an adult, age 18 or older.

All residents must have a pool pass to access the pool/tennis court areas. Passes will only be issued to the deeded homeowners. One pool pass per household. If your pass is suspended, all the members of the household are excluded

from the pool and tennis court. Guests are non-residents of The Glen. You cannot give access to a Glen resident who does not have a pool pass or whose pass has been suspended. If you have problems with your pool pass, please call Janet Georgi at 727-846-0701.

#### **Pool Passes**

All residents must have a pool pass to access the pool/tennis court areas. The cost is \$15 for new/replacement passes. Please call Sentry Management to set up a day and time to distribute the pass. Make your check payable to <a href="HOA of the Glen at River Ridge, Inc.">HOA of the Glen at River Ridge, Inc.</a>. Passes will only be issued to the deeded homeowners. No passes will be issued to minors. If you have problems with an existing pass, call Janet Georgi at 846-0701.

If you have your house for sale and have a pool pass, please return it to Tom Conner so he can update his records. These passes belong to The Glen Homeowners Association, not the homeowner. If you are moving, please call Tom Conner at 942-1906 ext. 53501 or Janet Georgi at 846-0701 to arrange for a drop-off of your pass.

Pool passes are issued to the property owner only. One pool pass per household. If your pass is suspended, all the members of the household are excluded from the pool and tennis court. Guests are non-residents of The Glen. You cannot give access to a Glen resident who does not have a pool pass or whose pass has been suspended. This is considered a violation.

#### **Pool Violations**

The following violations have been identified during the summer season at pool/tennis areas:

- Entering the pool area without a pool pass or climbing the fence.
- Use of pool when the pool is closed.
- Staying in the pool after the lights go on.
- · Playing with the life safety equipment.
- Leaving access gate open.
- Unable to verify valid pool pass.
- Children under age 14 not supervised by an adult (18 years or older).

#### Trespassing

We have several properties in our community that are vacant and are being used as play/parking areas. It is illegal to trespass on any property without the owner's permission. Liability and property damage may be subject to fines, restitution, and arrest. Remember, vacant property is not your property; trespassing is against the law.
